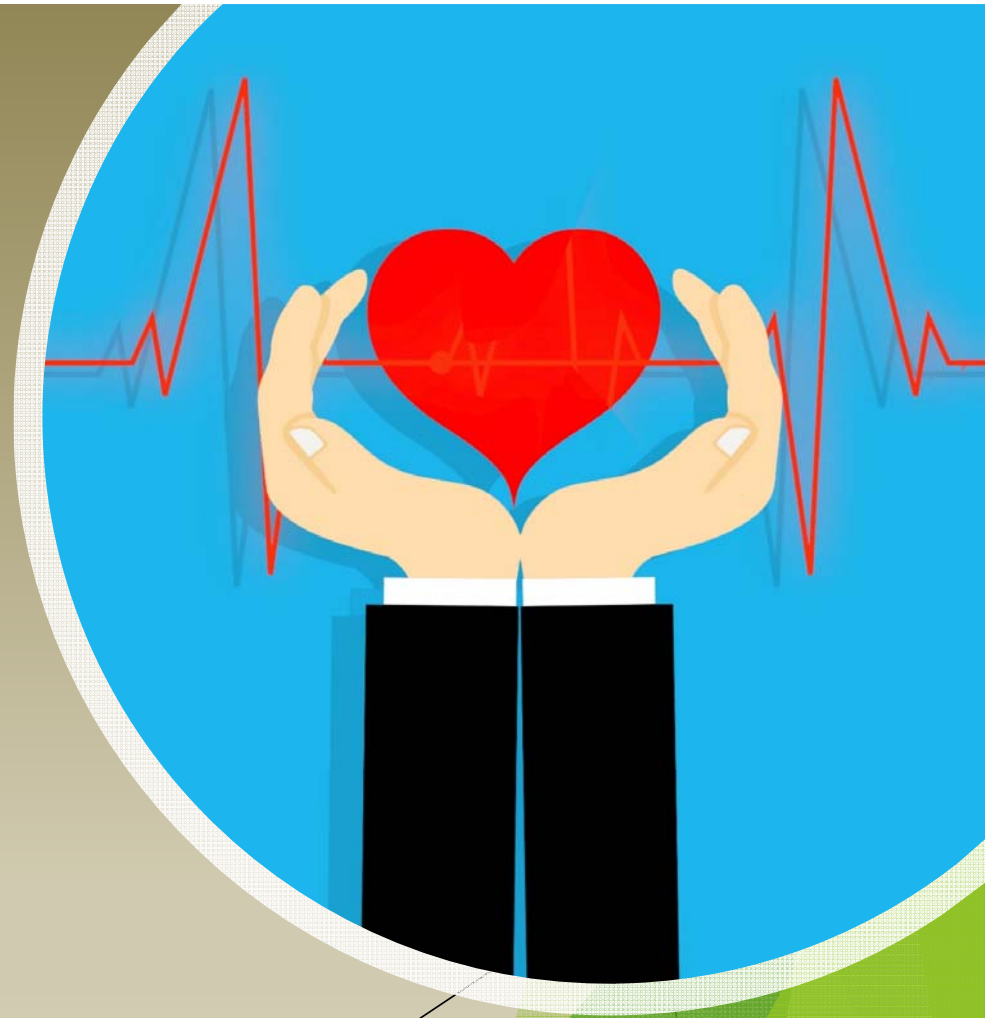

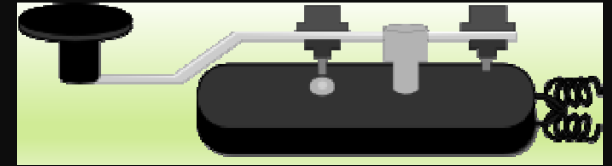

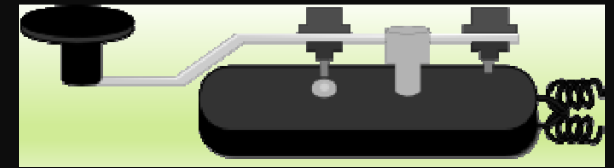


Notes: The FCC filed a Notice for Proposed Rule Making (NPRM) to start collecting a \$50 fee for Amateur Radio License Applications, Vanity Calls, Renewals and for a copy of your license. Currently, these are free. Comments are being accepted on the Notice of Proposed Rulemaking (NPRM) in MD Docket 20-270. They are also looking at taking 75% bandwidth to expand broadband.
